PRIVACY POLICY

INTRODUCTION

We at Redshift Cyber Security respect your right to privacy.

Where we refer to "personal information", it means "personal information" as defined in the Protection of Personal Information Act, 4 of 2013 ("POPI").

Personal information includes any information about a person that can be used to identify a person directly or indirectly. POPI includes the personal information of juristic persons in its ambit — so we will protect the personal information of juristic persons in the same manner as any other person's personal information.

We will take all reasonable steps to ensure that your personal information is protected. We are fully ISO27001:2022 compliant and apply all relevant controls to the protection of personal information. We protect and manage personal information that we hold about you by using electronic and computer safeguards like firewalls, data encryption, and physical and
